

Goldendoodles on the Hill

Health Warranty and Standard Contract

1. Seller guarantees that at the time of purchase, the puppy is in excellent health. Before sold all puppies will receive a thorough examination, immunizations/vaccinations/shots, microchipping, and de-wormer from a licensed and reputable veterinarian. Veterinarian records will be available at Buyer's request.

2. The following conditions apply to the sale of the puppy:

- Seller guarantees that at the time of purchase, the puppy is in excellent health. Before sold all puppies will receive a thorough exam, first set of shots, and de-wormer (at least twice) from a licensed and reputable veterinarian. Veterinarian records will be available for Buyer upon request.
- The Buyer has four (4) days from the time of receipt of the Goldendoodle to have the puppy examined by a licensed veterinarian. Should the puppy, during that time, be found by the veterinarian to be in poor health of a serious and life debilitating nature, Buyer has the option to request return of the purchased puppy to Seller for a full refund. For a full refund to be granted, this request must be made within 96 hours from the time of purchase. The Buyer can choose to keep the puppy and the Seller will reimburse veterinary costs, up the purchase price, directly related to the treatment of said pre-existing condition. Proof of the veterinarian's examination/conclusion and receipts must be provided. If the Buyer has not taken the puppy to a licensed veterinarian within four (4) days of purchase, this Health Warranty is void.
- Under no circumstances shall the Seller be liable to the Buyer or to any third party for any consequential, incidental or special damages resulting from or in a manner related to the puppy/dog.
- Under no circumstances shall the Buyer ever place or give the purchased Goldendoodle to a pound, shelter, or similar facilities. In addition, the Buyer agrees to never place or give the purchased puppy/dog to any research laboratory.
- If the Buyer finds that he or she, at any point during the course of the purchased Goldendoodle's life, is unable to provide adequate housing and/or care then contact with the Seller must be made immediately. Goldendoodles on the Hill and the Buyer will work cooperatively to secure quality rehoming for the dog.

- Upon execution of this Health Warranty and Standard Contract all veterinary care and its associated costs are the sole and exclusive responsibility of the Buyer.

3. Buyer agrees to maintain this puppy/dog in good health, provide routine preventative healthcare including, but not limited to: Vaccinations/Immunizations, Internal and External Parasites, Heartworm Prevention, Flea and Tick Control, Regular Baths, Grooming and any other preventative medication/procedures a licensed veterinarian deems necessary. If any of the above preventative care has not been provided, this Health Warranty will be void.

4. Goldendoodles on the Hill guarantees the Buyer an extended two-year warranty for the purchased puppy in relation to any congenital health defects of a life-debilitating nature. Should such a genetic disease/disorder be discovered during this time and the Buyer chooses to keep the puppy/dog, Seller will reimburse the veterinary costs up to the original purchase price. Confirmation of the disease being of genetic origin must be made by two licensed veterinarians and be provided to the Seller in order for reimbursement.

5. Under this two-year genetic health warranty, Buyer also has the option to return the puppy for a full refund of the purchase price. This guarantee only applies to the original purchase of the puppy and will be void if the condition was caused by injuries acquired through training, play, or other activities; or if the puppy has been neglected, malnourished, or allowed to become obese. Furthermore, if the latter has taken place consultation with the Goldendoodle Association of North America (GANA) will be made as to an appropriate response for care of the purchased Goldendoodle.

6. *All puppies purchased under the Standard Contract from Goldendoodles on the Hill are sold with the understanding and agreement that the puppy purchased WILL NOT be used for breeding and will be spayed or neutered no later than eighteen (18) months of age. Evidence of the puppy being spayed or neutered should be provided to Seller by no later than the twenty-first (21st) month of age.

*Under exceptional circumstances, breeding rights are available for purchase at the sole discretion of the Seller. Goldendoodles on the Hill unequivocally reserves that right. If breeding rights are granted for purchasing, the Specialty Contract will be used in lieu of this Standard Contract.

7. Buyer agrees that once a deposit of \$300 is given to the Seller in relation to the choice of purchasing a puppy, the Buyer is placed on the waiting list in order of deposits' given. A puppy is not chosen; a spot in line is afforded for placement of choice. Puppy deposits are NON-REFUNDABLE.

8. Buyer agrees that the puppy he or she chooses should be picked up by the Buyer no later than 8 weeks (56 days) after the day of the puppy’s birth, and that each day past the 59th day, the Buyer will be charged a puppy maintenance fee of \$20 per day, which the Buyer agrees to pay to the Seller.

9. Both Buyer and Seller agree that this Health Warranty and Standard Contract represents the entire agreement between both signatory parties and that no other representations have been made regarding any puppy purchased from Goldendoodles on the Hill. A copy of this Health Warranty and Standard Contract, the GANA Puppy Registration Certificate, and the puppy’s microchip registration information will be provided to the Buyer upon the completion of signatures by both parties.

By signing this document I acknowledge that I have read and agreed to the terms and conditions listed in this Health Warranty and Standard Contract.
